Set Up Your Ford Interest Advantage Online Access

1. Call **1-800-462-2614** and select option 5. Follow the instructions.
2. After two hours, go to **fordcredit.com/investor-center/interest-advantage**
3. Click on the "Access My Ford Interest Advantage" box located on the left side of the screen.
4. Read the "Terms and Conditions." To proceed, click "I Accept."
5. At the sign-on screen, type your Ford Interest Advantage number in the ID field.
6. Type in your password as instructed below:
 - Initial Login:**
 - Your initial password is the last four digits of the primary owner's Social Security number.
 - At the initial login, you will be prompted to change your user ID and password.
 - Subsequent Logins:**
 - After your initial login, you will use the new ID and password you have selected. (*Note: Keep your password confidential!*)
7. The initial screen that you see will be the Financial Summary view. This and many other pages on the site may be customized for your convenience.
